You may start at any property and we recommend going in numerical order, but you may choose any order you like. After property #10, you can loop back to #1 and keep going depending on which property you started with.

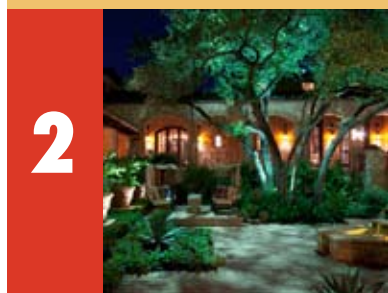
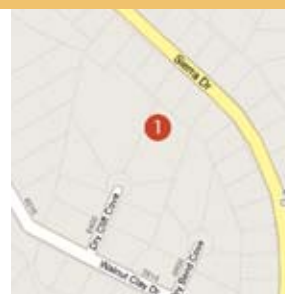

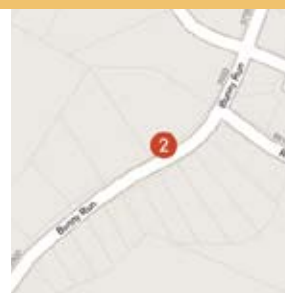
From Mopac. West on Far West. Left on Mesa. Left on Sierra. Right on Walnut Clay. Right on Dry Cliff Cove.
